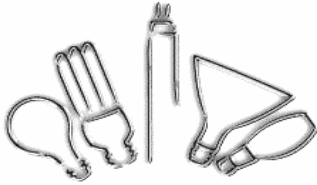

## TERMS AND CONDITIONS

Each item of information set forth in this CREDIT APPLICATION is warranted to be true and is given for the purpose of obtaining credit for the above named APPLICANT from THE LIGHTING COMPANY. In consideration of the said extension of credit, the APPLICANT and the undersigned, individually, jointly and severally, agree to pay all invoices for purchases made by APPLICANT, upon receipt. All payments are to be made at Corporate Offices of THE LIGHTING COMPANY, located at 1621 Browning Ave, Irvine, CA 92606. A minimum charge of 15% (fifteen percent) will be made to cover handling on all returned goods unless the goods are defective or an error exists on our part. APPLICANT and the undersigned, jointly, and severally, acknowledge that a service charge computed on the basis of 1.50% (one and one-half percent) per month of all sums due to THE LIGHTING COMPANY, which have not been paid within 30 (thirty) days from the INVOICE DATE, shall be charged to the APPLICANT and the undersigned. The APPLICANT and the undersigned, jointly and severally, agree to promptly pay said service charge. The service charge will be due and payable on the 31<sup>st</sup> (thirty-first) day after the INVOICE DATE and as additional service charge, computed on the same basis, shall be due and payable every 30 (thirty) days thereafter. Waiver of any one or more service charges shall not be deemed to be a waiver of any future service charges. Any controversy between the parties to enforce or interpret the terms of this agreement shall, on written request of one party, be submitted to arbitration in the City of Santa Ana under the existing rules of the American Arbitration Association for Commercial Arbitrations subject to confirmation under Code of Civil Procedures Section 1280 et seq.

The APPLICANT and the undersigned further agree that in the event THE LIGHTING COMPANY employs an attorney in order to secure payment of any sums due it from APPLICANT or the undersigned, the APPLICANT and the undersigned, jointly and severally, agree to pay to THE LIGHTING COMPANY all costs of collection and reasonable attorney's fees in addition to all other sums due hereunder.
